- a) Received final budget breakdown, Statutory Income & Expenditure and Cash and Investment Reconciliation
- b) <u>Accounting Statements 2021/22</u> **Noted** that the accounting statements have been submitted to the external auditor and the <u>Notice of Public Rights and Publication of Unaudited Annual Governance & Accountability Return</u> has been posted

#### Financial Year 2022/23 (current) -

- a) **Received** an up-to-date report on <u>expenditure in comparison with budget</u>. Councillor M Keeble asked about VAT and it was confirmed that all the accounts are net of VAT, the Clerk reclaims the VAT twice a year and the council was not currently VAT registered.
  - Councillor M Keeble confirmed that Shere Village Hall was happy to cover the cost of the movie license for the Drop-in Centre, Clerk to confirm amount.
- b) **Noted** current general and earmarked reserves Councillor C Carlisle asked for an update on the car park repairs and the Chairman replied that talks were still ongoing with the Trustees of Shere Recreation Ground about repairs and charging in the car park. It was acknowledged that repairs were a priority before winter.
- c) To consider any further expenditure for the year 2022/23 it was **Noted** that it is early in the year but it was acknowledged that due to the ongoing increases in cost of living, some budget codes were likely to be exceeded in the current year.

    - vi. Gomshall Veteran's Club
  - To defer the decision for a grant/donation to Shere recreation Ground until negotiations regarding the public car park conclude
