- PFSC/22.4 Peaslake Farm Development to receive an update on the Peaslake Farmyard development of affordable housing from Diana Kingdon and Vicki March, Greenoak Housing Association (GHA). The following position was reported:
  - GHA shortlisting builders as part of a two-stage tender
  - Chosen builder will be involved with the detailed design
  - Public consultation regarding the building phase, early December
  - Work begins end January/beginning February 2023
  - 45-week build late 2023 completion
  - Guildford Borough Council funding legal agreement with GHA to be shortly completed
  - Some site investigations still taking place and committee agreed to appoint a specific invasive species contractor to record and treat Japanese Knotweed liaising with GHA
  - Any increase in building costs to be absorbed by GHA
  - Completion of the contract with Shere Parish Council to be in next few months when final payment will be received. (Clerk to ask council solicitor to release deposit)
  - GHA Peaslake and Woking flagship schemes to be presented at an event in Woking with presentations and speakers invitations to follow.
