Construction of horse arena.

We are concerned about the expansion and increase in traffic. Restrictions on previous applications have been exceeded. We request for a condition that the arena is removed once it ceases to be used.

Listed Building Consent for the enlargement of existing rear dormer windows and minor rear ground floor fenestration changes.

The removal of the original window opening is damaging to the character of the listed building.

Variation of Condition 2 (external finishes to match) and Condition 3 (drawing numbers) of permission 13/P/02119 for the erection of a single storey rear extension, replacement roof with attic rooms, demolition of single garage and erection of double garage. Amendments to ridge height of double garage, cladding type and insertion of a rooflight in double garage.

Advertisement consent for an internally illuminated PID sign. **No objection.**

23/P/01527 Beech Tree Cottage, Sutton Place, Abinger Hammer

Proposed dormer to the rear of the property and changes to fenestration. **No objection.**

23/P/01503 High Steeps, Peaslake Lane, Peaslake

Erection of a new detached dwelling with access, parking, bins storage area.

Objection, detrimental to the AONB and loss of wildlife corridor.

Erection of a WildKitchen (retrospective application).
