Shere Parish Council raises no objection to this application and welcomes the applicant's commitment to addressing biodiversity matters in a thorough and constructive manner.

25/P/01001 - Meadow Cottage, Westfield, Hoe Lane, Abinger Hammer, Dorking, RH5 6RS Erection of first floor rear extension, addition of render and cladding to elevations and changes to fenestration and doors. Installation of solar panels to the main house and carport roof. No objection.

25/P/00967 - Netherlands Wood, Albury Estate, Guildford, GU5 9TE Proposed mixed-use forestry and sustainable eco-retreat comprising of 32 tourist cabin accommodations with associated facilities, landscaping, parking and access.

Shere Parish Council object to this planning application.

The site at Netherlands Woods is within the London Metropolitan Green Belt, the Surrey Hills National Landscape, an Area of Great Landscape Value, the Clandons Downs Site of Nature Conservation Importance, and the Biodiversity Opportunity Area: North Downs Scarp & Dip; Mole Gap to Reigate.

It also comprises ancient woodland (Plantations on Ancient Woodland Sites, or "PAWS"). Adjacent to and beyond the site boundary there are further PAWS, Areas of Ancient and Semi-Natural Woodland and Sites of Specific Scientific Interests.

There are no rights of way within the site, but the North Downs Way National Trail borders the site to the south and a public right of way follows the northern boundary of the site.

The proposal is to build 32 luxury one and two bedroom tourist cabins, each with a fire pit, dotted around the 80 acre site, as well as a service cabin, a wellness centre, a bin store, new tracks, and parking for both cars (38 spaces) and bicycles (64 spaces). This is a significant development in a unique, fragile and heavily protected site.

We have concerns about the harm to the site and to the surrounding areas that would result from the construction works themselves and from the ongoing activities, including footfall, traffic, light pollution, and the obvious fire risk posed by the fire pits.

Crucially, if this development were permitted to go ahead, it would cause irreparable harm to the site, its flora and fauna. It would fundamentally alter the nature, look and feel of the site itself and of the surrounding areas.

It is precisely to protect against developments like these that the Surrey Hills were designated an AONB in 1958 (now National Landscape), and that the site has been further designated as set out above.

Section 245 (Protected Landscapes) of the Levelling up and Regeneration Act 2023 places a duty on relevant authorities (including local authorities) in exercising or performing any function in relation to an AONB in England, to seek to further the statutory purpose of the area. The statutory purpose of the National Landscape is to conserve and enhance the area's natural beauty.

The National Planning Policy Framework and the Guildford Local Plan both require great weight to be given to conserving and enhancing the landscape and scenic beauty within National Landscapes and state that the scale and extent of development within these areas should be limited. Exceptional circumstances must be demonstrated to justify major developments. We consider the proposed development to be a "major development" for these purposes, and no exceptional circumstances exist or have been demonstrated.

Nature is our most precious asset, it is irreplaceable, and it must be protected. We invite you to deny this application, for which there can be no justification.
